- ¹ The credit rate for a particular school or average Tuition Level is subject to change in the event that the school, or a school included in the average, changes its tuition rate for academic year 2018-2019.
- ² Millersville University (PA Resident Rate), Indiana University (PA Resident Rate), Shippensburg University (PA Resident Rate), Mansfield University (All Rates), California University (Active Military & Family Rate), Slippery Rock University (Active Military & Family Rate), the PA College of Technology, and some community colleges (as indicated on this PA 529 GSP Credit Rate Schedule) charge only by the academic credit, not by the semester. Therefore, semester rates are not listed for those schools. For schools that charge a semester rate, the PA 529 GSP Semester Rate is the sum of either 12 or 15 GSP Credits, depending on the actual rate set by the school. See footnote 17.
- ³ Contributions and payments made at this Tuition Level will be calculated using the current freshman rate. Payments at this Tuition Level are available only to those Beneficiaries who are enrolled at East Stroudsburg University.
