- ¹ The credit rate for a particular school or average Tuition Level is subject to change in the event that the school, or a school included in the average, changes its tuition rate for academic year 2024-2025.
- ² Shippensburg University (PA Resident Rate), the PA College of Technology, and some community colleges (as indicated on this PA 529 GSP Credit Rate Schedule) charge only by the academic credit, not by the semester. Therefore, semester rates are not listed for those schools. For schools that charge a semester rate, the PA 529 GSP Semester Rate is the sum of either 12 or 15 PA GSP Credits, depending on the actual rate set by the school. See footnote 17.
- ³ In calculating the PA State System of Higher Education Average, the schools used are Bloomsburg, California, Cheyney, Clarion, East Stroudsburg, Edinboro, Indiana, Kutztown, Lock Haven, Mansfield, Millersville, Shippensburg, Slippery Rock, and West Chester.
